Category 2 Premises:	Rateable Value between £1 and £11,500	£800
Category 3 Premises	Rateable Value between £11,501 and £35,000	£1,100
Category 4 Premises	Rateable Value between £35,001 and £70,000	£1,300
Category 5 Premises	Rateable Value between £70,001 and £140,000	£1,700
Category 6 Premises	Rateable Value over £140,000	£2,000

The above fees are due on the date on which the application is received by the Licensing Board.

#### **Annual Premises Fee**

Category 1 Premises	£180
Category 2 Premises	£220

Category 3 Premises	£280
Category 4 Premises	£500
Category 5 Premises	£700
Category 6 Premises	£900

The first annual fee is due as follows:-

- For any licence that takes effect from 1st September 2009, on 1st October 2009
- In any other case, 30 days after the date on which the licence takes effect.

Thereafter, the annual fee is due to be paid on 1st October each year, or, where 1st October falls on a Saturday or Sunday, on the immediately following Monday.
