RULES AND CONDITIONS

This event will be conducted under the tournament regulations of the Scottish Badminton Union, including the prohibition of doping, for which tests may be carried out.

Competitors must be a member of a club affiliated to the S.B.U. or the S.S.B.U.

The committee reserves the right to refuse any entry without giving a reason and to alter the programme or the order of play if necessary.

Competitors entering the singles events must play in their own age group. They may however play in a higher age group for the doubles events but can only enter in one doubles event.

No entry will be accepted from any player who has taken part in any unauthorised tournament, league, or match.

Competitors must report to the referee on arrival in the hall.
Players absent when called to play may be scratched.

Nylon shuttles will be used for the 1996 and 1994 age group events and feather shuttles for the 1992 age group.

Games will be played in pools using the new scoring system and where the need arises pool winners will play semi-finals and finals.

Pool games will be 1 set of 21 points.

Entry fees must accompany the entry form.
