Subject to the following conditions:

- 1 The permission hereby granted shall, unless extended by the Roads Authority, expire at the termination of the above period.
- 2 Arrangements for the deposit, use and removal of the skip shall be in accordance with the requirements of Grampian Police and the Director of Infrastructure Services.
- 3 This consent may be removed at any time at the request of the Director of Infrastructure Services or a Constable in uniform.
- 4 The skip shall not exceed 5 metres in length by 2 metres in width.
- 5 The name and telephone number of the owner shall be clearly and permanently marked on the outside of the skip.
- 6 The ends of the skip (that is to say, the sides of the skip facing traffic in both directions when the skip is positioned as mentioned in condition 2 above) shall be painted yellow and there shall be attached vertically along the outside edge of each end so as to be visible to traffic, a strip of material the composition of which complies with the Builders Skips (Markings) Regulations 1984 (SI 1986 No 642 (S.61)) in having broad red fluorescent and yellow reflecting diagonal strips. The painting and the strip of material shall at all times be kept clean.
- 7 The skip shall be placed in the position specified in the permission, with its longer sides parallel to and about 300mm from the kerb and so sited as not to impede the drainage of the road or obstruct access to any manhole or apparatus of the local authority or of any statutory undertaker, with special emphasis on any fire hydrants and marker plates.
- 8 The contents of the skip shall be kept "damped down" to prevent nuisance from dust and any spillage on the road shall be removed immediately.
- 9 The skip shall not be used for the deposit of explosive, dangerous, noxious or offensive matter, or of a matter liable to putrefy.
- 10 The person carrying out the said operations shall be responsible for the removal and proper disposal of all materials placed in the skip whether by such person or any other either with or without authority.
- 11 The Roads Authority shall be indemnified against any liability, loss, claim or proceeding whatsoever arising in respect of the placing or maintenance of a skip on the road or its removal.
- 12 On removal of the skip, the site shall be left in a clean and tidy condition to the satisfaction of the Director of Infrastructure Services.
- 13 A fee of £25.00 per week shall be payable for this permission.
