Due to new developments on the north side of the B9032, Aberdeenshire Council are satisfied that it is necessary in the interests of road safety to extend the existing 40mph speed limit on the B9032, Muir Road from the eastern part of Memsie, by a further 201 metres to the east, to a point to the east of the access for the new developments on the north side of the B9032.



MEMSIE - PROPOSED 40MPH SPEED LIMIT


