A957 SLUG ROAD, STONEHAVEN - PROPOSED 30MPH SPEED LIMIT

The existing A957 has been upgraded to accommodate the new mixed use development on the northwestern periphery of Stonehaven. Aberdeenshire Council propose to extend the existing 30mph speed limit as detailed below in conjunction with these improvements in the interests of road safety.

From 143 metres or thereby from its junction with William Mackie Road, northwestwards for 540 metres or thereby including the roundabout.



STONEHAVEN - PROPOSED 30MPH SPEED LIMIT


Aberdeenshire Council proposes to make "The Aberdeenshire Council (A957, Slug Road, Stonehaven) (30 mph Speed Limit) Order 2023" under the Road Traffic Regulation Act, 1984.

The effect of the order will be to extend the existing 30mh speed limit on the A957, Slug Road, Stonehaven from 143 metres from its junction with William Mackie Road, northwestwards for 540 metres including the roundabout.
