U149M EASTER BALMORAL - PROPOSED CLEARWAY


Aberdeenshire Council proposes to make "The Aberdeenshire Council (U149M Easter Balmoral Clearway) Order 2024" under the Road Traffic Regulation Act, 1984.

The effect of the order will be to prohibit any person from driving any vehicle on the U149M Easter Balmoral from its junction with the B976, southwards for 500 metres, so as to cause that vehicle to stop.

ROAD TRAFFIC REGULATION ACT, 1984

THE ABERDEENSHIRE COUNCIL (U149M EASTER BALMORAL CLEARWAY) ORDER 2024

Aberdeenshire Council in exercise of the powers conferred upon it under the Road Traffic Regulation Act, 1984, and of all other enabling powers, and after consultation with the Chief Constable in accordance with Part III of Schedule 9 of the Act of 1984, hereby makes the following order:-

- 1. This order may be cited as "The Aberdeenshire Council (U149M Easter Balmoral Clearway) Order 2024", and shall come into operation on
- 2. Save as provided in Article 3 of this order, no person shall drive or cause or permit any vehicle to be driven on the U149M Easter Balmoral from its junction with the B976, southwards for a distance of 500 metres or thereby, so as to cause that vehicle to stop.
- 3. Nothing in Article 2 of this order shall apply to any person driving a vehicle so as to cause it to stop:-
 - (1) under circumstances of emergency, or upon the direction or with the permission of a police constable in uniform;
 - (2) in connection with building. demolition or maintenance works that have been authorised by the Aberdeenshire Council, or
 - (3) for the purpose of picking up or setting down a passenger.
