1. Overview

This document has been generated from information entered into the Integrated Impact Assessment system.

The Council currently allocates £9,000 annually to the Dee Catchment Partnership. Of this amount, £6,000 is provided through the Flood Management Budget, while the remaining £3,000 is sourced from the Environment and Sustainability and Natural Environment Planning budgets.

This Integrated Impact Assessment relates specifically to the cessation of the £6,000 annual contribution from the Flood Management Budget.
