#### 4. Justification

The embedded Planning Administration function support the statutory functions of Development Management (and Building Standards) and collectively frontload the planning application process (submissions/validation/payment/neighbour notification, adverts) and complete the backend of the process (issuing planning decisions) - performance is time critical & bound by statutory time indicators. Input to the Local Development Plan process also takes place. Not filling vacancies would have a significant impact on the planning application process - impact on submission of applications, validation of applications, neighbour notifications, statutory adverts & payment (front end of process) and significant delays would impact on performance and service delivery. In addition input to committee processes would be impacted upon. Ultimately any slow down in the planning process would impact on economic growth & delivery of a new LDP. Reducing admin support leaves areas of vulnerability where there is potential for an uplift in both planning applications, including major energy developments, building warrants and cyclical LDP tasks, which would overall increase pressures on the remaining staff. Whilst there will be a variety of impacts on customers and the provision of a strategically important statutory service, no formal assessment is considered applicable. A refocus on the current staffing structure and the ability to upskill staff to take on multiple tasks, will reduce elements of impact of service reduction.

The impact of the removal of 0.4 FTE would be lessened through process review and in some areas increased automation where applicable.
